IPv6 PI Assignments The Policy

➔ 6.5.8. Direct assignments from ARIN to end-user organizations

■ 6.5.8.1. Criteria

To qualify for a direct assignment, an organization must:

- ▶ not be an IPv6 LIR; and
- ▶ qualify for an IPv4 assignment or allocation from ARIN under the IPv4 policy currently in effect.

IPv6 PI Assignments The Policy (Cont.)

■ 6.5.8.2. Initial assignment size

- ▶ Organizations that meet the direct assignment criteria are eligible to receive a direct assignment.
The minimum size of the assignment is /48.
Organizations requesting a larger assignment must provide documentation justifying the need for additional subnets.
- ▶ **These assignments shall be made from a distinctly identified prefix and shall be made with a reservation for growth of at least a /44.**

IPv6 PI Assignments The Policy (Cont.)

■ 6.5.8.3. Subsequent assignment size

- ▶ Additional assignments may be made when the need for additional subnets is justified. When possible, assignments will be made from an adjacent address block.
