- Since March 2005, we use the name of IDNIC for our NIR services:
 - -IDNIC is the one division under APJII.
 - The other division under APJII are the IIX (Indonesian IXP)
- IDNIC do concentrate on the NIR issues.

- We have done 5 OPM since 2002.
- 2 Major SIG: NIR and IIX.
- Result: 16 Policy Documents, with:
 - 6 Policies on IIX services
 - 2 Policies on APJII services
 - 8 Policies on IDNIC services
 - 4 Operational Policies
 - 4 Informational Policies
 - 3 documents is still on draft and are not being agreed yet.



- Current issues under OPM 5:
 - 1. Small Multihoming fees:

OPM

- a. We going to create new category: In-Direct Member and Direct Member.
- b. The fees will be the same.
- c. Fees for Small Multihoming as the same with APNIC policy:
 - Start-Up:
 - a. IP Address: USD 8192
 - b. ASN: USD 500
 - c. Per-allocation fee: USD 0,10
 - Annual Fee:
 - a. USD 0,10/IP Address
 - b. ASN : USD 50
 - Education Institution: Start-Up are being reduced to USD 2500.
- d. We still need more clarification from APNIC before we can decide further.

- 2. Impact on APNIC fee for Small Multihoming under NIR:
 - a. In-Direct member (thru one of NIR Member) ?
 - b. Direct member to NIR ?
- 3. Historical Allocation under IDNIC:
 - a. The organisation want to register under IDNIC. Is it the same fees apply as for ERX-Transfer on APNIC ?
 - b. The current ERX-Transfer from ID, want to transfer their membership under IDNIC, what is the procedures ?
 - c. Impact on fee to APNIC ?
- 4. Current Fee Structure for IDNIC member:
 - a. Small, until /20: USD 700
 - b. Medium, until /19: USD 950
 - c. Large, More than /19: USD 1200
- **5. Suggestion for New APNIC Fee Structure:**
 - a. Fees for current member especially medium and large member are very high.
 - b. Most of our Small member will be impact directly with this new fee's.
 - Have to pay 2 times from the current fee and this is very high for development country like Indonesia.
 - c. Prefer to go back with the current fee.
