3. Membership

By the end of December 2006, APNIC had 1,362 members, serving 49 economies. In 2006, there is a net gain of 205 members, with 298 new members, whilst 93 members have been closed. Economies in which APNIC have the highest members are Australia (362 members), India (160 members), and Hong Kong (130 members).

Table below compares actual growth of membership with the budgeted growth in 2006. Overall, the variances demonstrate APNIC has gained more members than budgeted and has attracted significantly more members in higher membership tiers than the projected year to date growth, especially on the Small and Large membership tier.
