## **ARIN XXII Policies for discussion**

The submission deadline for policy proposals under consideration for inclusion on the ARIN XXII agenda was 16 August. The ARIN Internet Resource Policy Evaluation Process requires that proposed policies must be submitted at least 60 days prior to the meeting. As of 1 August 2008, 5 policies have accepted by the Advisory Council (AC) for discussion.

# **Caribbean Sector Meetings**



#### Kingston, Jamaica 21 May 2008

On 21 May, ARIN hosted a Caribbean Sector Meeting in Kingston, Jamaica. The meeting allowed Caribbean resource holders to provide input to the Advisory Council on active policy proposals currently under discussion in the ARIN region. Richard Jimmerson, ARIN Chief Information Officer, briefed the attendees on ARIN activities in the Caribbean, and made educational presentations with Leslie Nobile, Director of Registration Services, on ARIN's Internet Resource Policy Evaluation Process and existing ARIN number resource policy. The meeting was co-sponsored by Mona Information Technology Services and IEEE Jamaica Sector.

The meeting was held in conjunction with a CTU Workshop, and was attended by approximately 50 Internet service providers, network operators, Ministerial and Regulatory government officials, interest group members, Domain name operators, as well as other industry professionals living or working in the Caribbean.

#### Nassau, Bahamas 16-17 September 2008

Following a very successful meeting in Kinston, ARIN will return to the area to hold its second Caribbean Sector Public Policy meeting just prior to the ARIN XXII Public Policy and Members Meeting. In addition to the previously offered education and policy discussions, the ARIN Engineering department will be setting up a native IPv6 network for educational experimentation for the Tuesday morning session, followed by the CTU Workshop: Regulatory Innovation in the IP World.

The Wednesday sessions will be dedicated to the discussion of active policy proposals in the ARIN region and ARIN updates. The content of the policy discussions will be provided to the Advisory Council for consideration during their deliberations and will be published on the Public Policy Mailing List (ppml) in keeping with ARIN's open and transparent policy development process.

# **Ongoing Outreach Efforts**

ARIN outreach has been in high gear through the late spring and summer. ARIN staff traveled around the region to participate in a number of industry tradeshows and conferences. This fall ARIN will continue to reach out to inform the Internet Community about issues related to IPv4 depletion and to promote migration to IPv6.

# **Internet Governance Update**

Since joining ARIN, Cathy Handley, Executive Director of Government Affairs and Public Policy, has spent much time traveling to represent ARIN at various governmental and Internet Governance meetings. Her efforts have focused on contributing to discussions about the governmental implications of Internet community issues regarding IPv4 depletion and IPv6 adoption, and sharing information about what can be done to assist in the adoption of IPv6.

#### **Cathy's Travel Brief:**

MAY – Attended both the ITU-T SG2 and IGF planning meeting for IPv4 and IPv6 discussions. The goal was to develop positions for the upcoming ITU World Telecommunication Standardization Assembly (WTSA) with a focus on clarifying IP addressing issues. The meeting delegates were primarily government officials. She also participated in the Inter-American Telecommunication Commission (CITEL) meeting to develop positions on IP addressing for the upcoming WTSA, and represented ARIN at LACNIC XI in Salvador/Bahia, Brazil.

JUNE - Participated in Organization for Economic Co-operation and Development (OECD) Ministerial where she assisted in the development and presentation of the Technology Stakeholder Forum held during the event. This was a large international event with over 1,500 delegates, mostly from governments and government-sponsored organizations. She also represented ARIN at the ICANN meeting in Paris, France.

JULY – Cathy represented ARIN at both the Caribbean Association of National Telecommunications Organizations (CANTO) meeting and the Caribbean Telecommunications Union (CTU) Internet Governance Forum in Curacao, Netherlands Antilles.



#### **Elections**

The 2008 ARIN Election cycle opened in July when we solicited volunteers for the Nomination Committee and began to accept nominations for the 2 open seats on the Board of Trustees, the 5 open seats on the Advisory Council (AC), and the one open seat on the NRO Number Council (NC). The nominations period for candidates for the Board, AC, and NRO NC closed on 20 August. The slate of candidates will be announced, along with their biographies, on 11 September. At that time the candidates biographies and their responses to the expanded candidate questionnaires will be published on the ARIN website, and community members can begin to add their Statements of Support for community consideration.

ARIN is preparing a major voter mobilization campaign. The elected bodies should represent the diversity of ARIN's membership, and ARIN is stepping up efforts to promote wider community participation in the 2008 ARIN elections. Online voting will open at 12:00 PM EDT (UTC/GMT -4 hours ) on 17 October, the final day of ARIN XXII in Los Angeles. Online voting will be enabled through 12:00 PM EDT on 24 October, with winners announced on 31 October. ARIN XXII meeting attendees, and those viewing the webcast will have an opportunity to hear speeches from the candidates during the Members Meeting on Friday, 17 October.

All member organizations are encouraged to verify their voter eligibility by 3 October, as they must have a valid designated member representative (DMR) and meet all Member-in-Good-Standing criteria to be eligible to vote. E-mail info@arin.net to verify your eligibility or update your DMR info.

#### **Revised NRPM**

A revised Number Resource Policy Manual (NRPM 2008.3) became effective on 5 August 2008, incorporating the adopted Policy Proposals 2008-1 and 2007-21. Policy Proposal 2008-1 added the option of reporting utilization using SWIP or RWhois to report reassignments smaller than /29s. Policy Proposal 2007-21 allows legacy IPv4 space holders to qualify for IPv6 space by registering their legacy holdings using the Legacy RSA. Both of these policies were adopted by the ARIN Board of Trustees on 8 July 2008.

Global policy 2007-23: End Policy for IANA IPv4 allocations to RIRs was adopted by the Board at the meeting on 8 July 2008, and ratified by the ICANN Board on 31 July. It will be incorporated into the next NRPM update.

# **4-byte Autonomous System Numbers**

As of 1 January 2009, ARIN will issue four-byte Autonomous System Numbers by default. Two-byte ASNs will still be available, but must specifically be requested. In accordance with globally-coordinated policy, ARIN and all the Regional Internet Registries began allocating four-byte ASNs by request in January 2007. January 2009 marks the transition, as required by existing policy, for ARIN to allocate four-byte ASNs by default.

Network operators may find themselves with a new four-byte ASN that cannot be recognized by upstream providers, peer networks, and customers. Timely vendor support is necessary to avoid a situation where network operators' routers and network administration systems that will not accept the expanded four-byte number format. ARIN urges operators to verify their vendors' routers will support four-byte ASNs.

APNIC has set up a special website at http://icons.apnic.net to help vendors understand how to provide four-byte ASN support and to help network operators find products that support four-byte ASNs.
